In signing or emailing this form, I declare that:

- 1 I am not a prohibited person within the meaning of Section 21 of the Firearms Act 1968 (as amended).
- 2 I meet at least one of the following conditions:
 - a. I hold a Firearm Certificate permitting me to use the firearms that I shall fire in this competition for target shooting.
 - b. I am a full member of a Home Office Approved Club, will be shooting as a full member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 (as amended).
- 3 Any ammunition I use will not exceed the range safety limits of 2,145 fps velocity AND 1495 ft-lb muzzle energy.
- 4 I agree that results and classifications may be published on the internet or elsewhere. (Please note that only your name, competitor number, class and score will be posted.)
- 5 I agree to abide by the Rules of the Meeting and I will accept the decisions of the Match Director as final.
- 6 I will comply with the mandatory requirement for eye and ear protection.
